Dear Ms. Jerry,

In response to your letter of June 3, 2019:

- 1. The project is displacing a conference room and offices.
 - a. Explain where the conference room and offices will be relocated;

The offices and conference room you reference will be relocated to the Performance Improvement (PI) offices on the east end of the construction area. PI staff are being relocated to a building currently owned by RRMC on Commons Street.

b. Identify the cost associated with this relocation;

The total cost associated with this relocation is \$125,000. \$100,000 of the cost is for the renovation of the PI and Commons Street spaces. The other \$25,000 is the cost to move the existing PI and PSIU furnishings and equipment from the current locations to the new locations.

c. Explain whether the associated relocation cost is included in the total project cost; and

The renovation cost is included in the total project cost (see below).

d. Identify the line item(s) where the relocation costs are included. If not included in the total project cost, please explain.

The \$100,000 is included in Table 1 as part of the \$2,647,643 reported on the *Renovation* line under the *Construction Costs* section.

The \$25,000 is included in Table 3B titled *Income Statement - Project Only* on the *Other Operating Expense* line for FY 2020 along with \$10,000 for Asbestos Abatement. This \$25,000 is included as an operating expense and is not part of the capital costs included in Table 1 due to Accounting Standard Requirements. Accounting Standards state that all costs related to moving and storage of existing furnishings, fixtures, and equipment may not be capitalized and instead must be included as an operating expense. (Accounting Standards also require that asbestos abatement related costs be included as an operating expense.)

2. There is a discrepancy in the fundraising amount reflected on page 12 of the application and Table 3B, titled *Income Statement*, in Exhibit F. Please explain.

The fundraising amount of \$500,000 listed on page 12 of the application is incorrect. The fundraising amount of \$550,000 included on Table 3B, titled *Income Statement - Project Only* on the *Non-Operating Revenue* line for FY 2020 is correct.

3. Submit a letter signed by your architect certifying that all architectural plans meet or exceed all applicable FGI Guidelines for a facility of this type.

The renovations of the 4th floor adult inpatient service unit is a project designed to address deficiencies related to existing physical plant ligature risks. The assessment of the existing physical plant was conducted by Lavallee Brensinger Architects and in conjunction with RRMC's clinical staff. The team evaluated each space and assigned a *risk level* as outlined in the *Design Guide for the Built Environment of Behavioral Health Facilities*. The project used this assignment to identify deficiencies and to outline the statement of corrective actions.

In accordance with FGI Section 1.1-3 Renovation, all new work shall comply with both the Guidelines and the applicable occupancy chapter of NFPA101. The renovations included in this project have been designed to meet these Guidelines. It should be noted that access to existing bathrooms currently require patients to enter a corridor, this existing condition is not be altered in this project. New patient rooms being added will have bathrooms that meet this criterion.
