Statutory Duties: Budget & Core Activities

➤ 18 V.S.A. § 9375: Annually review the budget and all activities of VITL and approve the budget, consistent with available funds, and the core activities associated with public funding, which shall include establishing the interconnectivity of electronic medical records held by health care professionals and the storage, management, and exchange of data received from such health care professionals, for the purpose of improving the quality of and efficiently providing health care to Vermonters. This review shall take into account VITL's responsibilities pursuant to section 9352 of this title and the availability of funds needed to support those responsibilities.



Proposed Statutory Duties: H.901 of 2018

- ➤ 18 V.S.A. § 9375: Annually review the budget and all activities of VITL and approve the budget, consistent with available funds, and the core activities associated with public funding, which shall include establishing the interconnectivity of electronic medical records held by health care professionals and the storage, management, and exchange of data received from such health care professionals, for the purpose of improving the quality of and efficiently providing health care to Vermonters of the Vermont Information Technology Leaders, Inc. (VITL). This review shall take into account VITL's responsibilities pursuant to section 9352 of this title and the availability of funds needed to support those responsibilities.
- ➤ Annually review and approve the budget, consistent with available funds, of the Vermont Information Technology Leaders, Inc. (VITL).

- ➤ Review Budget in May
- ➤ Materials submitted one week prior to presentation
 - ➤ Narrative regarding opportunities, challenges, methodology and strategic objectives
 - ➤ Audited Financial Statements
 - > IRS Form 990
 - ➤ Contracts with DVHA (stand-in for core activities)
 - ➤ Organizational Chart
 - ➤ Follow up from previous year's budget order
- Quarterly Reporting



Statutory Duty: Connectivity Criteria

- ➤ 18 V.S.A. § 9375: Review and approve the criteria required for health care providers and health care facilities to create or maintain connectivity to the State's health information exchange as set forth in section 9352 of this title. Within 90 days following this approval, the Board shall issue an order explaining its decision
 - ➤ VITL required to present connectivity criteria to GMCB annually
 - ➤ GMCB approval required by March 1st annually



Staff Recommendation: Connectivity Criteria

➤ **Staff Recommendation:** Approve connectivity criteria as presented by VITL (no changes), with an order to require a substantive update by the end of 2018, developed in conjunction with the HIT Plan process
