## Hospital Financial Assistance during COVID-19

a. How have you changed your official or unofficial patient financial assistance policies and/or procedures during COVID-19?

We did not change our Financial Assistance Policy during COVID-19, however we did offer the following:

- All self-pay patients have been mailed Financial Assistance Applications during this COVID-19 pandemic. We also mailed applications to under-insured patients with balances over \$999.
- Self-pay admissions were screened by a Financial Counselor and enrolled for Medicaid if applicable. If not eligible for Medicaid, patient was screened for FAP and given the material to apply.
- b. How have you handled patient collections during COVID-19?

We have continued collections during COVID-19. We will be implementing longer statement periods for patients by the end of June. Statement cycles will move from 30 days to 60 days allowing patients more time to make arrangements or to apply for assistance.

Provider Recruitment

a. How (if at all) have you leveraged the federal J-1 visa waiver program in your recruitment of health care providers?

Rutland Regional participates in the Conrad 30 waiver program for J-1 foreign medical graduates who are sponsored by their employer to work under H-1B status for at least three years. The H-1B program is like the J1 program, but it has advantages for recruiting and retaining physicians for longer terms of employment. Rutland Regional has hired five physicians through the H-1B program over the last five years. The physicians include one psychiatrist from Canada, another psychiatrist from Pakistan who is also trained in addiction medicine, one hospital medicine physician from Canada, one endocrinologist from Canada, and one pulmonologist from Germany who is also trained in critical care medicine. Rutland Regional has successfully sponsored one of the psychiatrists to convert their visa status to permanent residency status (Green Card) and is in the process of sponsoring three of the other physicians for permanent residency.
