Dear Ms. Jerry:

This letter is to request an extension to the Certificate of Need (CoN) for the Construction of Medical Office Building; Renovations to Loading Dock, Dietary, Vermont Orthopedic Clinic; and Upgrades to Site Drainage and Detention Pond System. This CoN was issued on January 23, 2018 and required that the project be fully implemented within three years of the date of issuance. It was recently brought to our attention that a request to extend this CoN was due prior to January 23, 2021. Due to delays resulting from the COVID-19 pandemic, we are requesting that this CoN be extended for 12 months, from January 23, 2021, to January 23, 2022.

Due to the COVID-19 pandemic, Phase 1 (Medical Office Building and Loading Dock) work decreased beginning in mid-February 2020 ascribable to reduced crews and travel restrictions for out of state workers. A Vermont State order ceased construction for 6 weeks (March 23 until April 20, 2020), then there was a slow re-start due to State restrictions of no more than two people working together inside and continuation of travel restrictions for out of state workers. We also had slowdowns caused by contractors with COVID outbreaks and not being able to receive the vaccine as well as product and material not available or on backorder for a long period.

Phase 1 was originally slated to be complete in June 2020, but the MOB and Loading Dock were turned over to RRMC at the end of September 2020. Phase 2 (remodeling of the former VOC building) was also behind schedule due to the COVID-19 pandemic. The expected completion of January 2021 was first moved to July 2021 and is now estimated to be complete in January 2022. Although construction is 98% complete and staff were moved into the renovated office space at the end of June, we are still awaiting a few outstanding work items that relate to backordered building supplies. We expect these items to arrive in the early fall and will need time to install and compete project closeout procedures.

This project is expected to be on budget. RRMC has been able to manage the delays in the project and the increase in supply costs with the use of contingency funds which allowed us to remain with budget. RRMC included \$1,027,435 of construction contingency which offset the overruns in the construction and site work costs. The remaining contingency funds are expected to be used to close out the final phase of the project.
