Dear Ms. Jerry,

As requested, please find responses to further inquiries from your July 28, 2022, letter regarding North Country Hospital's proposed project.

- 1. In your response to the second set of questions, question 5, and fourth set of questions, question 11, NCH responded that "the project is not forecasted to increase payer rates", and that the rate increases of 4.2% in FY 2023, 3.2% in FY 2024, and 2.2% in FY 2025, built into the model were only to cover normal operational expense increases. However, it has come to our attention that NCH has requested a 12.45% increase in rates in its recent hospital budget submission. Confirm whether NCH's prior response that the project is not expected to increase payer rates is still accurate. Also, please confirm whether the requested 12.45% increase in FY 2023 is included or excluded in the financial tables you have submitted for the project.
 - The campus project does not seek to increase payer rates to support replacing our 50+ year old infrastructure. NCH budget submission for FY23 is reflective of nationally high inflation currently impacting normal operating expenses. The 12.45% increase is not reflected in the financial tables, nor do we expect inflation to remain this high in the future.
- 2. In addition, NCH has represented that if needed, NCH has sufficient reserves to finance the total cost of the project (\$27,898,176) with reserves alone which would decrease Days Cash on Hand from 291 to 172. Given NCH's reserves, please explain whether there have been any changes in NCH's financial situation and whether the hospital's financial situation is still strong enough to implement the project at this time.
 - NCH is experiencing short term cash flow challenges with implementation of

our new Cerner EMR system in mid-May. As with all EMR conversions, this is expected to subside in 9 to 12 months. Regardless, NCH cash reserves remain strong considering \$15M has already been set aside in a money market account not impacted by current investment volatility. Approval of CON will greatly enhance NCH's ability to pursue alternative capital grants such as New Market Tax Credits, USDA financing, and other such resources. For example, on August 15, NCH will be working with Newport City to formally apply for a \$1M grant. Even without these additional capital opportunities, NCH has the resources to fund this campus project.
