Re: GMCB-017-21, Feel Like Oh Yeah, LLC Request for Jurisdictional Determination and Exclusion Under 18 V.S.A. § 9435(a) for Practitioners of the Healing Arts

Dear Green Mountain Care Board:

We are writing to request the Board consider our outpatient, regenerative medicine pain clinic exempt from Certificate of Need as an office of practitioners of the healing arts. This letter is in response to your July 2022, questions and is informed by our office's operations to date. The regenerative medicine services we provide are office services performed by us and other Vermont practitioners (as well as in other states) and are "usually performed by such providers on an outpatient basis" as explained. There are no overnight stays as part of our services; all services have outpatient CPT codes.

Please note that we have previously submitted our first year of actual expenditures and continue to hold annual operating costs under \$500,000 while this exemption request is pending.

The field of regenerative medicine, the use of the body's own healing properties to restore and heal damaged tissue and cells to normal functioning, has been around in one form or another for over 150 years. Skin grafting in the late 19 century is considered the first form of regenerative medicine. Ever since World War One the medical community has been very aware of the healing properties of plasma. The term "Regenerative medicine" was first used 30 years ago by Leland Kaiser in 1992 in an article on hospital administration where he accurately predicted: "A new branch of medicine will develop that attempts to change the course of chronic disease and in many instances will regenerate tired and failing organ systems." The term was popularized in 1999 by William Hazeltine at a conference at Lake Como stating that regenerative medicine is "an approach to therapy that ... employs human genes, proteins and cells to re-grow, restore or provide mechanical replacements for tissues that have been injured by trauma, damaged by disease or worn by time" and "offers the prospect of curing diseases that cannot be treated effectively today, including those related to aging".

Today regenerative medicine, the use of blood products like platelet rich plasma including blood proteins like Alpha 2 Macroglobulin, and autologous stems cells is widely studied and used. At QC Kinetix we use regenerative medicine to treat musculoskeletal joint pain. It is commonly accepted that musculoskeletal joint pain is a prevalent condition and one whose occurrence increases with age -- as a graying state it's a significant health issue.

Regenerative medicine is a rapidly emerging field. It's a multi-disciplinary area of medicine, meaning there are cardiologists, orthopedic surgeons, sports medicine providers, chiropractors, physical therapists all doing these types of treatments. Medical providers in Vermont are already successfully providing regenerative medicine services as described more later.

Under our supervising physician, Don Pham, D.O., our Physician Assistant, Jeremy Orr, PA-C, and Nurse Practitioner, Emily LeVan, NP-C perform our services. We use all-natural non-surgical techniques, common amongst other practitioners including orthopedists, chiropractors, naturopaths, and various practitioners of physical medicine using the patient's own biologics to alleviate and treat musculoskeletal joint pain.

Per GMCB Rule 4.000 § 4.205 (a) – (h) please consider the following:

- (a) **Billing procedures used**. We bill patients directly; our services are not covered by health insurance.
- (b) **Structure of ownership**. Feel Like Oh Yeah, LLC Vermont single-member LLC Tom Lee, of Underhill, is the single member.
- (c) **Training and specialties of the staff**. All staff receive role-specific QC Kinetix initial and on-going training, coaching and support. QC Kinetix has developed strict care standards and operational procedures to maintain consistency across its network. The staff consists of 6 part-time employees as follows:
  - a. Supervising Physician Don Pham, DO (Vermont license 32.0133902) experienced and specializing in the use of natural biologics in the treatment of joint pain in several other clinics. (contract employee)
  - b. Procedure Specialist: Jeremy Orr, PA-C (Vermont license 55.0030644). (0.25 FTE). Performs patient exams, and all procedures and injections.
  - c. Procedure Specialist: Emily LeVan, NP-C (Vermont license APRN 101.0085969) (Per Diem fill-in only) Performs patient exams, and all procedures and injections.
  - d. Medical Assistant/Phlebotomist (0.25 FTE). Performs blood draws, process the blood to concentrate the healing properties and readies the resulting biologics for injections.
  - e. Consultation Coordinator (non-medical staff) (0.35 FTE)
  - f. Front Desk Representative (non-medical staff) (0.25 FTE)
- (d) **Procedures performed**. Many of our procedures are commonly used in offices of orthopedists, chiropractors, massage therapists, and other practitioners of physical medicine, etc. We treat adults 18 years and older. The following is a listing of various conditions that we treat in our Colchester VT location:
  - a. Knee pain from a partially torn tendon, ACL, ligaments, or meniscus
  - b. Back pain including sciatica and lumbago
  - c. Shoulder pain including strains, sprains, or torn rotator cuff

- d. Elbow pain such as from tennis elbow or golf elbow
- e. Hip pain
- f. Various other musculoskeletal pain such as plantar fasciitis, tendonitis, muscle tears, ligament tears, and bursitis.
- g. Other joint pain due to various arthritis such as osteoarthritis, rheumatoid arthritis (not a disease modifier), and psoriatic arthritis.

The following procedures are used in different combinations and frequencies in proprietary protocols based on the provider's medical judgment. All biologics are derived from the patient's own body, and once concentrated, are injected in their affected joints during the same-day visit to our clinic. No biologics are ever stored in any way. All services are outpatient services conducted onsite at our Colchester VT location. Our procedures are as follows:

- a. Class IV deep tissue laser treatment (CPT code 97039) to reduce inflammation, improve blood flow, alleviate pain, and promote healing in joints. We use a non-ablative class IV laser for tissue heating, not destruction or alteration, so the laser we use is not surgical. This is the same treatment used by NFL teams to help players recover week to week and is commonly available in offices of various physical medicine practitioners, physical therapists, chiropractors, etc.
- b. PRP therapy. Blood draw of up to 120 ccs (about a syringe full) then separation and concentration of various healing and regenerative properties in the patient's own blood including platelet rich plasma and alpha 2 macroglobulin protein (CPT Code 0232T) by way of a centrifuge, and FDA-approved filtering kits. These autologous biologics are then reinserted into the patient's affected joint or joints to promote soft tissue healing, regrowth, and serve to reduce inflammation from arthritic conditions.
- c. Bone marrow aspirate concentrate (CPT Code 38220). We aspirate bone marrow from the iliac crest of the patient's hip using a needle under local use of lidocaine. This aspirate is then separated via the centrifuge, filtered, concentrated, and reinserted in the patients affected joint. This produces a

much higher concentration of autologous stems cells to promote healing and regrowth of soft tissue and cartilage.

Our various procedures are widely practiced in other modern countries and have been selectively available in the United States for several decades. QC Kinetix is working to make these procedures available to a much wider variety of patients seeking non-surgical, non-pharmaceutical improvement of joint pain surgery, steroids, cortisone, or the use of drugs. We treat damaged joints, muscles, tendons, ligaments, cartilage and tissue where damage is due to injury or arthritis to decrease pain, improve mobility and return quality of life. These treatments are used locally for musculoskeletal injections but are not used for systemic diseases or administered intravenously.

- (e) Patient referral patterns and relation to other healthcare institutions. We receive referrals from chiropractors, massage therapists, physical therapists, orthopedic physicians, or simply through word of mouth. Many of the patients are already managing a musculoskeletal diagnosis. We refer to other providers such as to orthopedists, sports medicine specialists, radiology, chiropractic, etc. when appropriate and in the patient's best interests.
- (f) **Type of diagnostic and other equipment purchased**. We use the following standard equipment in our clinic:
  - i. GE VScan hand help ultrasound for guided injections
  - ii. EMCYTE Platinum Series Centrifuge
  - iii. CENTRIFUGE POWERSPIN LX 6PL/ W/ 4000RPM
  - iv. Progressive Electrical Therapeutics Class IV Deep Tissue Laser.
- (g) Representations of the facility to the public. QC Kinetix offers an all-natural alternative to surgery or the use of drugs in treating musculoskeletal joint pain. We use the best healing properties from the patient's own body to stimulate natural regeneration of soft tissue resulting in the relief of much joint pain. When our patient first calls to inquire about our free initial consultation they are screened for qualifying conditions, made aware that our services are not covered by insurance, and are told that the typical cost is \$4,000 to \$8,500 per joint treated. All of our Vermont advertising complies with Vermont Act 61 2021. Only once the patient is aware of the above do we schedule their initial consultation.

- (h) The frequency with which other Vermont practitioners offer the same services. Other physicians, chiropractors, physical therapists, orthopedic practices and practitioners of physical medicine offer similar or identical procedures described in section (d) above. Please see attached partial listing of regional practitioners of the healing arts who are performing identical procedures the three procedures we perform in our clinic.
  - In Vermont a minimum of 25 practitioners' offices are performing Class IV Deep Tissue Laser Therapy procedures. See Table 1 for a sampling. According to Accuflex Laser & Technology, distributor of Progressive Electrical Therapeutics CLASS IV Deep Tissue Laser model that we use

there are over 300 other practices using this same model nationally. Additionally, there are three other manufacturers selling similar models including Aspen Laser, Lightforce Laser, and Summus Medical Laser.

- In the Northeast states (New England plus New York, New Jersey, and Pennsylvania) a minimum of 37 practitioners' offices are performing PRP Therapy services. See Table 2 for a sampling.
- In the Northeast states (New England plus New York, New Jersey, and Pennsylvania) a minimum of 27 practitioners' offices are performing Bone Marrow Aspirations/Stem Cell Therapy services. See Table 3 for a sampling.

Our uniqueness comes from the order and frequency of these common medical procedures in protocols that have been studied and modeled by QC Kinetix network. Our exact procedures are being performed in 138 offices across 32 states with a consistent safety record. The franchised system of operation has created a highly efficacious standard of care, with strong quality control and industry leading insight into advances in treatment. We perform our treatments within strict guidance of the franchisor creating excellent consistency and efficacy levels as evidenced by strong patient satisfaction surveys. Also, as a franchise of the QC Kinetix, we benefit from national leadership providing timely updates regarding FDA regulations and best practices on medical techniques. We receive and are trained to an Operational Manual that provides and regularly updates operational and clinical protocols and standards (used within the medical judgement of our providers) – despite being a small practice we are able to benefit from the experience and expertise of others through the QC Kinetix relationship to benefit our patients' experiences.

#### Franchise arrangement:

Feel Like Oh Yeah, LLC is a locally owned and operated franchise location of QC Kinetix. QC Kinetix's expertise is currently being used in over 138 clinics nationally. Feel Like Oh Yeah, LLC has entered an Area Developer Franchise Agreement with QC Kinetix for the territory of the Burlington-Plattsburgh DMA (designated market area). Our first location is Colchester, VT. Feels Like Oh Yeah, LLC paid QC Kinetix for a ten-year, renewable franchise for this designated market area. We also receive ongoing coaching and the benefits of continuous quality improvement across all practices. We also separately purchase, on an ongoing basis, support such as staff education and training, consulting physician hotline support and others – each is reflected on the operational cost spreadsheets previously submitted.
