Re: Letter of Intent to File Application Seeking Certificate of Need
The Pines at Brattleboro Center for Nursing and Rehabilitation

Dear Ms. Jerry:

This firm represents Brattleboro Crossings LLC (the "Applicant") d/b/a Pine Heights at Brattleboro Center for Nursing and Rehabilitation ("Pine Heights"). This is a Letter of Intent for a renovation project of Pine Heights, in accordance with Chapter 221 of Title 18 V.S.A. The Applicant will be filing an application for a Certificate of Need ("CON") for a proposed project to make significant renovations at Pine Heights at Brattleboro Center for Nursing and Rehabilitation.

Pine Heights is an existing, fully occupied, 4-story skilled nursing facility located in Brattleboro, Vermont. The proposed project involves interior renovations to the first floor, third floor, and fourth floor nursing units and includes all new finishes (floors and walls), painting of existing hung acoustical ceiling grids and panels, new ceiling grid and panels in certain locations, new lighting and new millwork. Areas of minor construction will involve replacing ceramic tile wall and floors within the existing shower suites. Other areas of construction will include the creation of a med room behind each nurse's station, relocation of the clean work rooms, refresh of the nourishment areas, refresh of existing recreation / dining rooms and the creation of a new oxygen closet. Work will also include replacement of existing lighting fixtures, existing electrical devices and plates to hospital grade devices, a new nurse call system (4th floor only), various HVAC and plumbing upgrades and repairs. New resident furniture will also be provided.

In summary, the majority of the work involves finish upgrades within the existing nursing units, with some construction taking place in a few areas to better suit the needs of the residents and the staff within the nursing home.

The Applicant acknowledges that the Green Mountain Care Board has statutory jurisdiction over this project, under 18 V.S.A. § 9434. We are writing to provide the Board with preliminary information to commence the CON process.

residents will be relocated within the facility while their rooms undergo upgrades. Subject to adjustment, the Applicant plans on performing the renovations in ten (10) phases, 4 phases for the 3rd floor, 4 phases for the 4th floor, and 2 phases for the 1st floor.

The Applicant previously submitted a CON application for this project, but the pandemic put that application on hold. This would be a new application for the same project, with updated information.

Please let me know if there is anything more the Board needs to determine what NHCA should provide and address in its application.

I look forward to working with you on this matter.
