OneCare Vermont FY 2021 Budget Hearing

Victoria Loner, Sara Barry, and Tom Borys were sworn in by the Court Reporter. Victoria Loner discussed the ACO's role in achieving a high-value health care system, the 2021 participants, Vermont's reform model, 2021 accountability, the ratio of OneCare Vermont (OCV) operating expenses to total healthcare accountability, and OCV's budget support of health care providers'

participation in value-based care. Tom Borys presented the value-based care programs, the 9.4% growth in scale-target attribution, the 17.1% growth in health care accountability, the significant reductions in risk, and the risk model evolution. Tom Borys presented the 2021 OCV budget, which included revenue highlights, expense highlights, Population Health Management investment areas and recipients, the full OCV ACO accountability budget, the income statement, and the balance sheet. Sara Barry presented the 2021 Population Health Management programs, the core activities in four categories, a care coordination story, the 2019 quality of care rates and the 2022 targets, and 2021 focus areas.
