Executive Director's Report

Vermont hospitals are currently strained, and the data being looked at by the contractors was prior to the pandemic. Hospital Sustainability and Healthcare Affordability: Analyses to Inform Act 159 of 2020 Section 4 Report

Alena Berube, Strategic Advisor on Health Policy & Finance

Alena Berube thanked the GMCB staff, hospitals, and stakeholders and reviewed what led up to the work required in Act 159 of 2020. Alena Berube explained how the work was defined and the project approach and recognized that we are currently still in a pandemic and experiencing a surge in capacity at VT hospitals. Examination of Payment and Cost Coverage Variation Across Payers for Hospital Services

Mark Podrazik, Managing Director, Burns and Associates, a Division of Health Management Associates

Mark Podrazik presented the high level of key findings of the study, the study's objectives, the terminology, the data sources used in the study, the dataset preparation, the inpatient and

outpatient service categories, an illustration of assigning cost values to claim lines, the application and computation of hospital case mix scores, and the hospital case mix scores using all payer weights computed. Mark Podrazik then described in detail each of the key findings and the application of the results from the study. The presentation can be seen here on the GMCB website. The Board Members had a discussion and asked Mark Podrazik questions regarding how the information might be used by the GMCB and hospitals, Federal limitation on payment amounts, payer mix and the cost shift being linked to sustainability, and possibly using cost reports in the hospital budget regulatory process.
