Draft Health Care Workforce Strategic Plan: Board Review and Feedback

The Board Members discussed that the plan should include short-term, medium-term, and long-term accountability for accomplishments, the need for the Board and the public to get periodic updates from the interagency task team, prioritization of recommendations, reporting of providers' practicing of full or part time in OPR's licensing census, and the importance of the K-12 pipeline.
