Sarah Kinsler and Marisa Melamed reviewed the Accountable Care Organization (ACO) oversight statute and rule, the ACO oversight timeline, what the Board will consider in the budget hearing, the All-Payer Model (APM) targets, the FY22 budget guidance summary, and the agenda for the hearing. The court reporter swore in the OneCare Vermont (OCV) presenters. Victoria Loner discussed OCV's continuous advancements toward value-based care, CMS's goal for all Medicare beneficiaries to be in an accountable care relationship by 2030, OCV's takeaways from the NORC evaluation of the APM, and OCV's core capabilities (network performance management, data and analytics, and payment reform). Dr. Carrie Wulfman discussed provider perspectives. Sara Barry and Dr. Carrie Wulfman discussed OCV's quality and care model, the value-based incentive fund, the care coordination program, the 2022 network accountabilities, actionable data and insights for providers, the financial performance report, the primary care panel report, and lessons learned. Tom Borys discussed the ACO provider community, the ACO payer programs, total cost of care, and risk management. Tom Borys presented OCV's FY22 budget in detail.
