**Certificate of Need (CON) Hearing: The Collaborative Surgery Center (CSC), Proposed Ambulatory Surgery Center in Colchester**

Susan Ridzon presented on why Vermont needs the CSC, which is a 9,000 sq. foot, four operating room facility in Colchester, that would serve northern Vermont. Susan Ridzon explained that adding the CSC would assist in shortening wait times for certain procedures and lessen costs and reiterated their commitment to donate 50% of the profits back into the community. **Essential Health Benefits (EHB) Benchmark Plan Updates**

Emily Brown presented the legislative mandate surrounding the EHB plan and design and reviewed the EHB plan analysis timeline. Emily Brown, with assistance from Julie Peper, Principal and Senior Consulting Actuary with Wakely, presented the Wakely EHB Overview and potential 2024 changes. The Wakely presentation reviewed some key points including federal regulations of the EHB, benefit comparisons, benefit pricing, and non-EHB considerations.
