**Rutland Regional Medical Center (RRMC) Mid-Year Budget Adjustment Hearing**

Chair Mullin called the meeting to order at approximately 8:00 am. The court reporter swore in the witnesses from RRMC, Claudio Fort, CEO and Judi Fox, CFO. Judi Fox presented the 2022 forecast for RRMC, where they are projecting a loss of 7.5 million dollars. Judi Fox explained the major drivers in terms of the deficit which included increased staffing costs, the impact of travelers, and inflationary pressures. Judi Fox reviewed the retention and recruitment challenges, which is the most significant operational challenge, and shared some recruitment strategies.

Judi Fox presented the revenue, expense and operating margin trends based on first quarter results. Judi Fox reviewed the balance sheet strength and explained the days of cash on hand along with the investment return. Judi Fox concluded with a summary of the budget adjustment request, targeted rates and RRMC's historical rate of increase. [The RRMC presentation can be seen here on the GMCB website.](#)

The Board Members asked questions about spending on advertising, use of reserves, total margin projections, the limiting of clinical services in the event that the increase is not approved, rate increases, polling staff for ideas, and the payer mix details.

Russ McCracken reviewed the GMCB rule 3.000 regarding budget performance review and adjustment. Patrick Rooney presented the reason for the RRMC budget modification request and an overview of the financial updates. Patrick Rooney presented the request from RRMC which would be a 9.0% change in rate, and the financial impact of that change. Patrick Rooney provided history on the NPR/FPP, operating margins, cash on hand and age of plant from 2017-present. Patrick Rooney stated the GMCB staff recommendation is to approve the request and provided suggested motion language. [The GMCB staff presentation can be seen here on the](#)
