**Executive Director's Report**

Chair Mullin called the meeting to order at approximately 8:30 am. Susan Barrett announced the [Certificate of Need \(CON\) Bulletin 004](#) would be posted by the end of the day. Susan Barrett announced we had received a response from the Agency of Human Services Secretary regarding additional federal funds and summarized the letter. Susan Barrett reviewed [the open special comment periods on the GMCB website](#).

Chair Mullin announced that after 5 years as Chair of the Board, he plans to retire this summer. His last day with the Board will be July 9, 2022.

**University of Vermont Health Network (UVMHN) Mid- Year Budget Adjustment Request – GMCB Staff Presentation and Recommendation – Potential Vote**

Patrick Rooney summarized the public comments received and the majority themes of those comments and reviewed the Board's legal authority around budget review and adjustment. Patrick Rooney reviewed the University of Vermont Medical Center (UVMHC) Net Patient Revenue (NPR) and explained the UVMHC and Central Vermont Medical Center (CVMC) requests for budget modification. Patrick Rooney presented the UVMHC and CVMC projections with and without the rate increase, the days cash on hand, operating margins, and the change in charge. Patrick Rooney reviewed the revenue impact for both UVMHC and CVMC. Patrick Rooney presented the GMCB staff recommendation which is to approve a rate increase not to exceed 3.5% for both UVMHC and CVMC and provided suggested motion language. The Board Members asked questions about and discussed the operating margins from years past, trying to push this adjustment into the FY23 hospital budget process, inpatient volumes and average length of stay, days cash on hand and Medicare dollars, retention payments and the

inflation table data, network hospitals in other states, the cost shift, and the current bond rating. A potential vote on the UVMHN mid-year budget request was scheduled for a Board Meeting on April 8, 2022.
