**University of Vermont Health Network (UVMHN) Mid- Year Budget Adjustment Request – Potential Vote**

The court reporter swore in the witnesses. Patrick Rooney reviewed the public comments received, the request for budget modification, and the University of Vermont Medical Center (UVMHC) and Central Vermont Medical Center (CVMC) operating margins and change in charge. Patrick Rooney presented the updated information provided by UVMHN and the updated staff recommendation which is to approve a rate increase of between 2.7%-3.0% for both UVMHC and CVMC. Patrick Rooney provided suggested motion language. The Board Members discussed the necessity of a mid-year rate increase.

Board Member Lunge moved to approve a mid-year budget adjustment for CVMC with the rate to be determined in a second motion. Board Member Holmes seconded the motion. The Board voted (3-2) by roll call to approve the motion with Board Member Pelham and Board Member Walsh voting no.

Board Member Lunge moved to approve no more than a 2.7% rate increase for CVMC for the approved FY22 budget, which is tied to adjusted inflation to mitigate projected margin erosion and provide hospital leadership financial flexibility to meet the unforeseen circumstances related to workforce and other cost pressures. Board Member Holmes seconded the motion. The Board voted (3-2) by roll call to approve the motion with Board Member Pelham and Board Member Walsh voting no.

Board Member Lunge moved to approve a mid-year budget adjustment for UVMHC with the rate to be determined in a second motion. Board Member Holmes seconded the motion. The Board voted (3-2) by roll call to approve the motion with Board Member Pelham and Board Member Walsh voting no.

Board Member Lunge moved to approve no more than a 2.5% rate increase for UVMMC for the approved FY22 budget, which is tied to adjusted inflation to mitigate projected margin erosion and provide hospital leadership financial flexibility to meet the unforeseen circumstances related to workforce and other cost pressures. Board Member Holmes seconded the motion. The Board voted (3-2) by roll call to approve the motion with Board Member Pelham and Board Member Walsh voting no.
