<u>Dartmouth Leadership Preventive Medicine Residents (LPMR) Clinical Perspective on</u> Hospital Sustainability and Updates on Health Equity

Dr. Henry Feng presented an overview of who the LPMR are and what their interests are and presented a scenario about who they care for. Dr. Henry Feng presented a scenario explaining the patients that are cared for, and a day-to-day in the life of a clinician, including what is seen and what happens behind the scenes. Dr. Henry Feng provided some comparisons for review, and which is better for the patient versus the bottom line. Dr. Henry Feng explained that there is work to be done when it comes to healthcare and understanding the patient population and their needs is immensely helpful.

Dr. Anais Ovalle presented an overview of what health equity means, how to achieve it, and what health inequity means in comparison. Dr. Anais Ovalle reviewed factors that determine health and social determinants of health and presented guidelines for measuring health equity.
