

## CON Monetary Jurisdictional Thresholds

April 5, 2023



### **Legal Context**



- Many of the triggers for CON review have a "monetary jurisdictional threshold" in them.
  - E.g., "The purchase, lease, or other comparable arrangement of a single piece of diagnostic and therapeutic equipment for which the cost, or in the case of a donation the value, is in excess of \$1,000,000.00."
- The GMCB may adjust these thresholds, provided that adjustments do not exceed the cumulative rate of inflation (measured by CPI).
  - 18 V.S.A. § 9434(e): "The Board may periodically adjust the monetary jurisdictional thresholds contained in this section . . . <u>Any adjustment by</u> <u>the Board shall not exceed an amount calculated using the cumulative</u> <u>Consumer Price Index rate of inflation</u>."

### **CON Bulletin 004**



- On March 30, 2022, the GMCB voted to increase each monetary threshold by **12.8%**, the seasonally adjusted rate of growth in the Consumer Price Index for All Urban Consumers (CPI-U), all items, between July 2018 the last time the General Assembly amended the thresholds and February 2022.
  - Growth in CPI-U, medical care, over the same period was 10.21%.
- The increases were implemented through an administrative bulletin.
  - The law used to require that adjustments be made by rule, but this requirement was eliminated in 2018.

### **Potential Revisions**



Growth in CPI-U, all items, between July 2018 and February 2023 is approximately **20.02%**. Growth in CPI-U, medical care, over the same time period is approximately **13.07%**.

    - UVMMC EMR Replacement: \$109.25M (increased \$15.7M in 2020 with expansion)
  - 2019
    - UVMMC construction of replacement building for Essex Adult Primary Care: \$8.62M
    - RRMC renovation of psychiatric unit to remediate ligature risks: \$4.07M
  - 2020
    - SVMC construction/renovation of ED and front entrance: \$25.8M (\$31M by 2022)

    - Belonging Medical Group expansion to become Spoke provider: \$1.19 \$1.48M
