1. GMCB Updates

- a. Susan Barrett, Executive Director, GMCB and Christina McLaughlin, Health Policy Analyst, GMCB presented an update on the Board's recent work and items related to the 2021 legislative session. Group members asked questions and provided comment on unmerging the small and individual markets for plan year 2022, the All-Payer ACO Model Agreement, provider reimbursement, and the narrative around fee-for-service versus value-based care.
- b. Future meeting topics: Group members suggested discussing how common terms related to provider reimbursement, such as fee-for-service, has a different meaning to administrators and clinicians and how to assess the right model(s) for provider reimbursement. 2. COVID-19 Updates & Lessons Learned

- a. Members were asked to provide updates to the Board related to the discussion questions:
 1. How has COVID-19 impacted you and how you a. deliver care (as a provider, physician, nurse, pharmacist, etc.), b. receive care (as a patient), or c. operate your business (hospital, private business, insurer, etc.)?
 2. What are some successful COVID-19 response strategies you have seen deployed, and what can we learn from them?
 3. What changes or improvements would you like to see continue in our health care system beyond COVID-19?
- b. Discussion Notes:
 - Out-patient joint replacement procedures have increased due to the COVID-19 pandemic, which is safer and less expensive for patients.
 - There should be a focus on what will impact provider practices in the future.
 - There is concern about health care utilization over the next few years. Many patients stopped receiving care in the past year due to the pandemic.
 - Telemedicine has been very helpful, but providers also need to see patients in person to make sure they are getting proper care.
 - Emergency department utilization dropped significantly during the pandemic and providers learned lessons on how to manage respiratory illnesses.
