

STATE OF VERMONT  
CONTRACT AMENDMENT

It is hereby agreed by and between the State of Vermont, Green Mountain Care Board (the "State") and Oliver Wyman, LLC, with a principal place of business at 1166 Avenue of the Americas, New York, NY (the "Contractor"), that the contract between them originally dated as of July 3, 2023, Contract #46012 (the "Contract"), is amended by revising section 1 to read as follows:

1. **Parties.** This is a contract for services between the State of Vermont, Green Mountain Care Board (hereinafter called "State"), and Oliver Wyman, LLC, a Delaware limited liability company, with a principal place of business at 1166 Avenue of the Americas, New York, NY 10036 (hereinafter called "Contractor"). It is Contractor's responsibility to contact the Vermont Department of Taxes to determine if, by law, Contractor is required to have a Vermont Department of Taxes Business Account Number.

The State acknowledges and agrees that Contractor is entering this agreement on behalf of itself and as agent for each of its affiliates based in Canada, if any, that may provide services under this agreement, and that Contractor will bill and collect on behalf of such Canadian affiliates amounts payable to them pursuant to this agreement and remit to them any amounts collected on their behalf.

Taxes Due to the State. Contractor certifies under the pains and penalties of perjury that, as of the date this contract amendment is signed, the Contractor is in good standing with respect to, or in full compliance with a plan to pay, any and all taxes due the State of Vermont.

Child Support (Applicable to natural persons only; not applicable to corporations, partnerships or LLCs). Contractor is under no obligation to pay child support or is in good standing with respect to or in full compliance with a plan to pay any and all child support payable under a support order as of the date of this amendment.

Certification Regarding Suspension or Debarment. Contractor certifies under the pains and penalties of perjury that, as of the date this contract amendment is signed, neither Contractor nor Contractor's principals (officers, directors, owners, or partners) are presently debarred, suspended, proposed for debarment, declared ineligible or excluded from participation in federal programs, or programs supported in whole or in part by federal funds.

Contractor further certifies under pains and penalties of perjury that, as of the date this contract amendment is signed, Contractor is not presently debarred, suspended, nor named on the State's debarment list at: <http://bgs.vermont.gov/purchasing-contracting/debarment>
