Minutes

Chair Mullin called the meeting to order at approximately 1:00 pm. The Board voted (5-0) to approve the minutes from November 18, 2020.

Executive Director's Report

Susan Barrett announced [the December 2020 Board Meeting schedule was posted on the GMCB website](#) and reviewed the schedule. Susan Barrett introduced the presentation from the Agency of Human Services on the All-Payer Model (APM) Implementation Plan and explained that the intention was to have the independent Board publicly discuss the regulatory strategies outlined in the plan.

All-Payer Model (APM) Implementation Improvement Plan

Secretary Smith spoke to the intention of the All-Payer ACO Model Agreement Implementation Improvement Plan and the importance of a value-based payment system. Ena Backus described the collaboration with the GMCB as cosignatories of the APM and the four key areas the implementation improvement plan focused on (using and maximizing Federal partnership, reorganizing and prioritizing the program in AHS, regulation recommendations for the GMCB, and strengthening the Accountable Care Organization leadership strategy).

The Board Members had a discussion with the presenters and asked questions regarding leadership for the APM, the Medicare risk corridor reduction past 2021, distribution of risk across the system, Dartmouth Hitchcock participation, tactics under recommendation seven, value-based incentives, the impacts of recommendation fourteen, potential studies on low value care, the proposed path for the Medicare payment model to mirror Vermont Medicaid Next Generation fixed prospective payments, outreach to providers regarding the benchmark, timing

of the Medicaid pilot with the HIE plan, the care navigator tool, the feasibility of the Blueprint for Health recommendation, commercial payer participation, the timelines of conditions eight and nine, the benchmark plan, the cost shift, implementation of recommendation seven, the ACO leadership strategy, the integration of the ACO and Blueprint for Health, and resources for social determinants of health discovered by recommendation sixteen. Alena Berube reviewed the content of the response draft, the draft strategies for increasing Medicare scale, the draft strategies for increasing All-Payer scale, and next steps.
