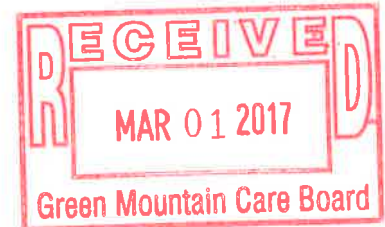

Dear Donna,

In reviewing our responses to Questions 006, posed on August 25, 2016, we noticed that the ownership table that we submitted inadvertently misstated two of the initial capital investment amounts. Specifically, the initial capital investment of Investor F was \$6,000 (not \$9,000, as stated in our prior response) and the initial capital investment of Investor G was \$9,000 (not \$7,500, as stated in our prior response). As a result, the total initial capital investment equals \$291,000 (not \$292,500, as stated in our prior response). We are accordingly now submitting a corrected version of the table, to replace the incorrect version of the table that was included in our prior response.
