Introduction of The Expenditure Analysis

The *Vermont Health Care Expenditure Analysis* is required under 18 V.S.A. § 9375a.

The analysis is an annual report to inform policy makers and the public about health care spending in Vermont. The report serves as a guideline within which health care costs are controlled, resources directed, and quality and access assured.

The report is a consistent model that:

- establishes a base of health care spending and funding,
- examines spending and sources of funds over time,
- allows comparisons of Vermont spending to national health care spending, and,
- provides spending information from two different perspectives; 1) spending on behalf of Vermont residents regardless where they receive care and 2) spending by Vermont providers for both residents and non-residents cared for in Vermont.

Executive Summary

As required under Act 160 of 1991 (Adj. Sess.), the Vermont Health Care Expenditure Analysis was first published in May of 1993. The report was intended to inform the development of a spending forecast and ultimately, a Unified Health Care Budget. The report was designed to allow comparisons with federal data reflected in the National Health Accounts published by the Health Care Financing Administration (renamed the Centers for Medicare & Medicaid Services [CMS] in 2001). The report has evolved to inform health care reform efforts as data sources and technology provide improved information.

Vermont resident health care spending

Health care spending for Vermont residents receiving services both in and out-of-state **increased 2.9% in 2015**. This was lower than the 4.7% increase in 2014 and below the average annual increase of 4.1% for the period 2006 through 2015.

Vermont compared to United States

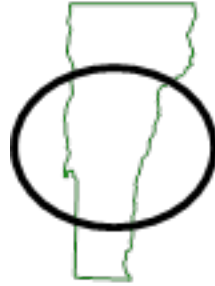
The per person spend in Vermont was \$9,112, an increase of 3.0% over 2014. This is lower than the U.S. per person amount of \$9,504.

Vermont provider health care spending

Health care spending by Vermont providers' services to patients increased 5.5% in 2015. This was higher than the 1.9% increase in 2014 and higher than the average annual increase of 4.7% for the period 2006 through 2015.

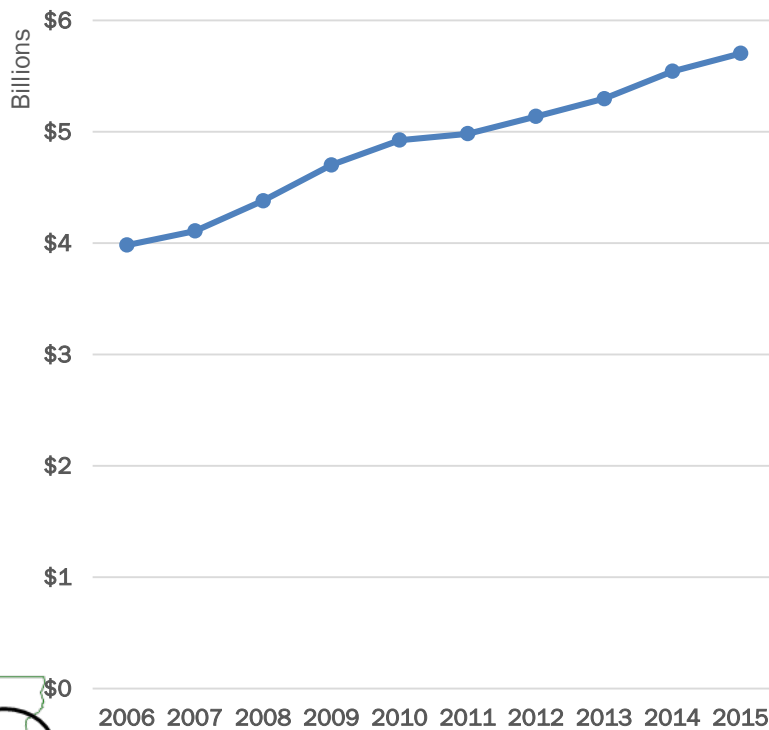

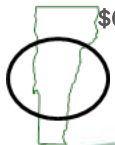
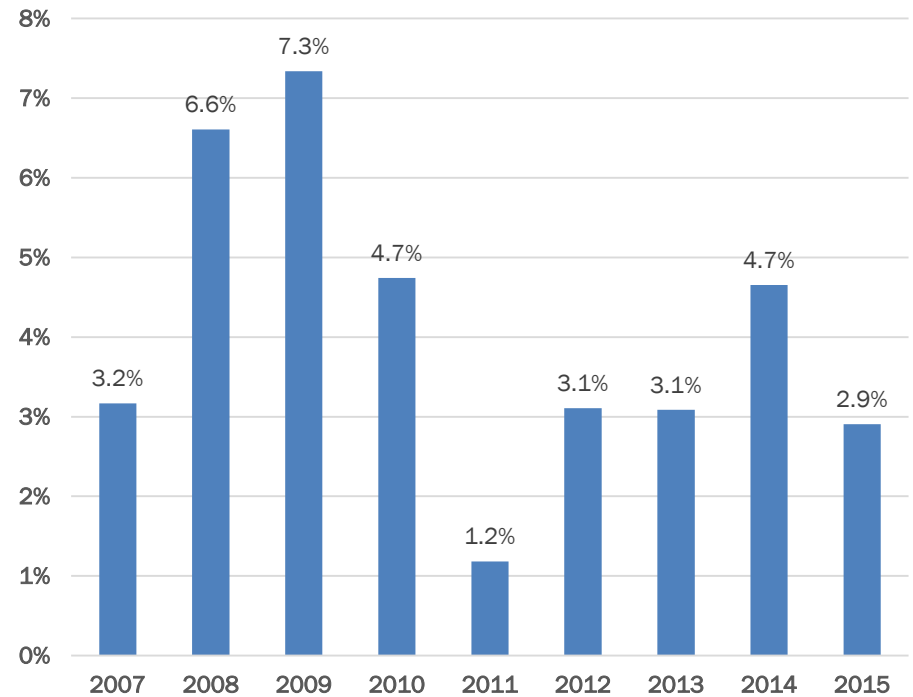
2015 Vermont Resident Analysis

VT Total Annual Spending

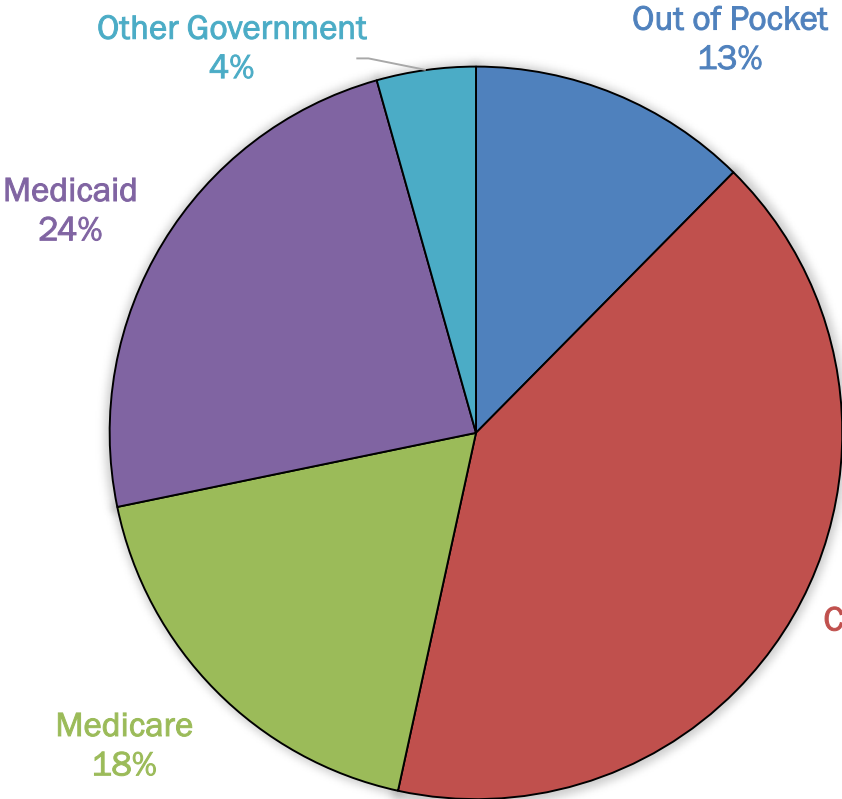


Total Annual Spending Growth

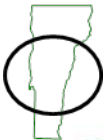
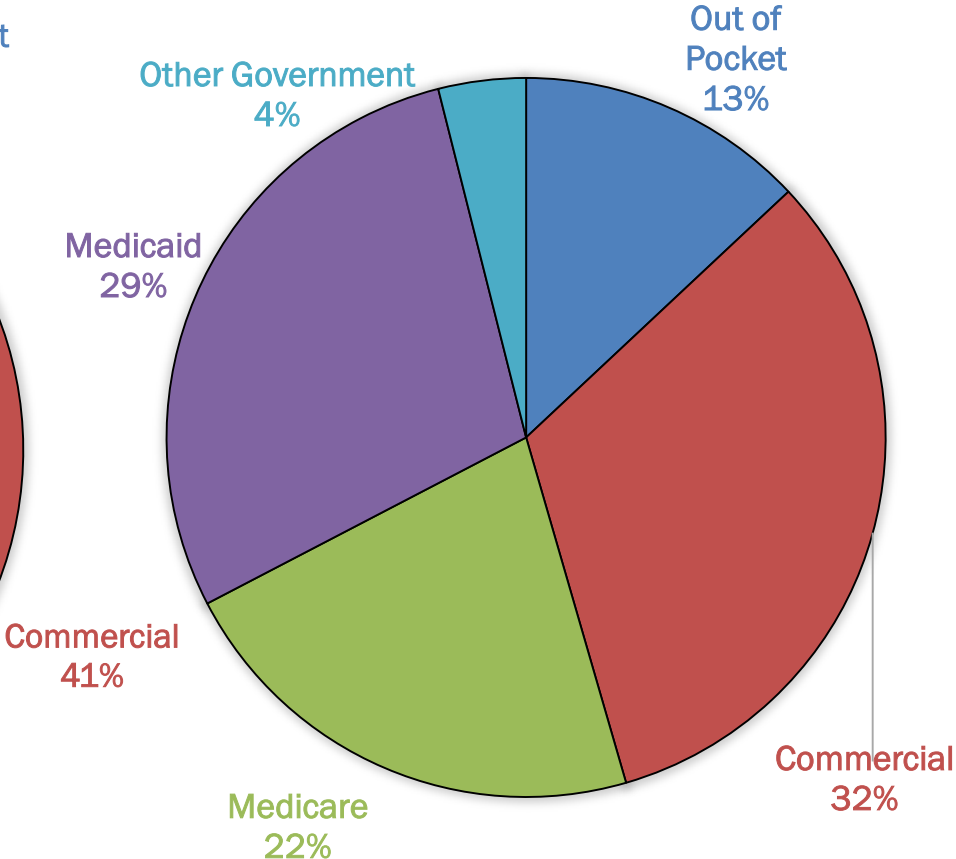

Total 2006 Spending \$4.0 billion

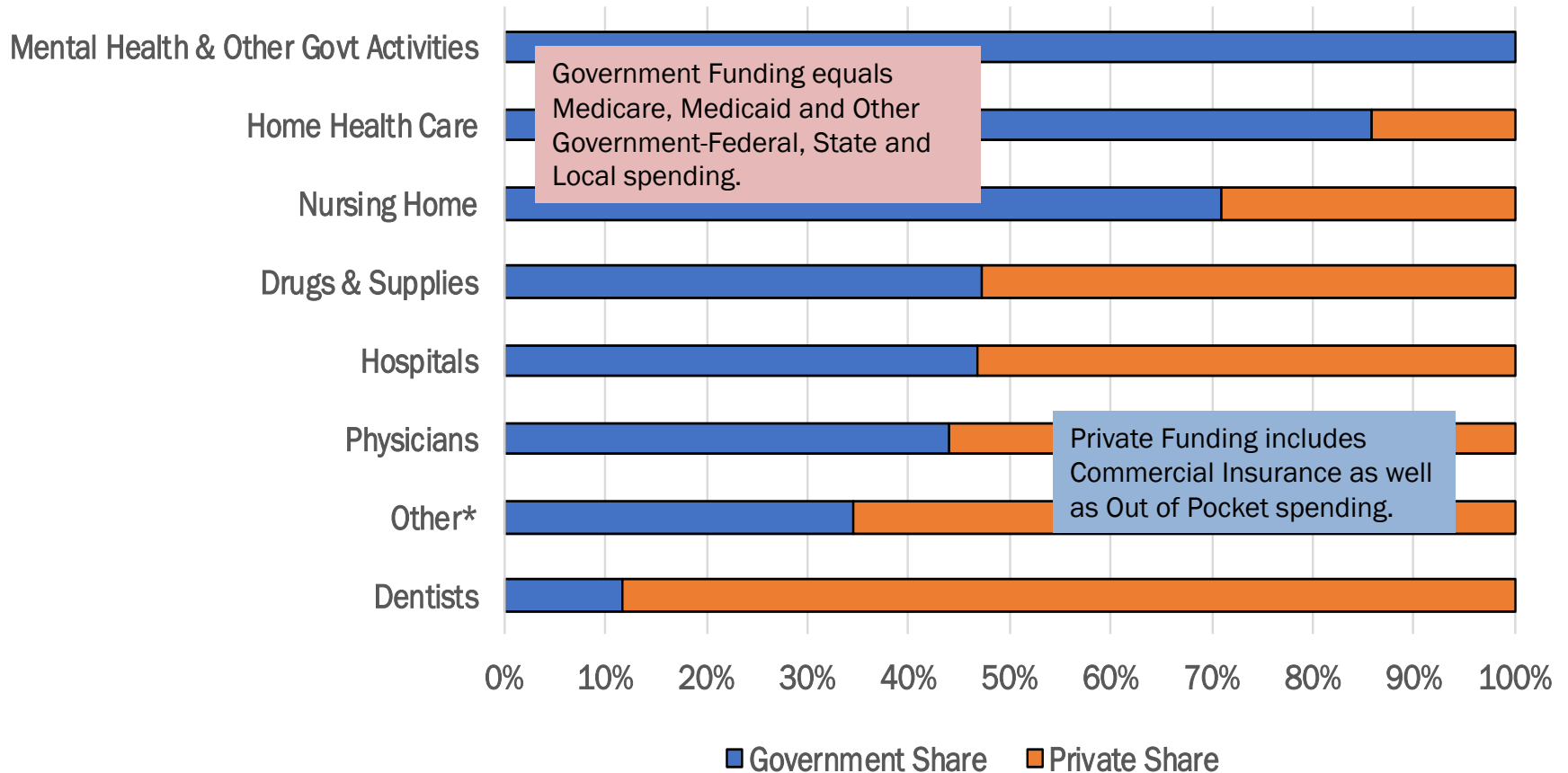


Total 2015 Spending \$5.7 billion

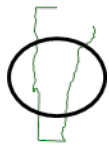

Government vs. Private Funding

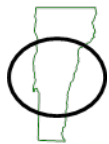
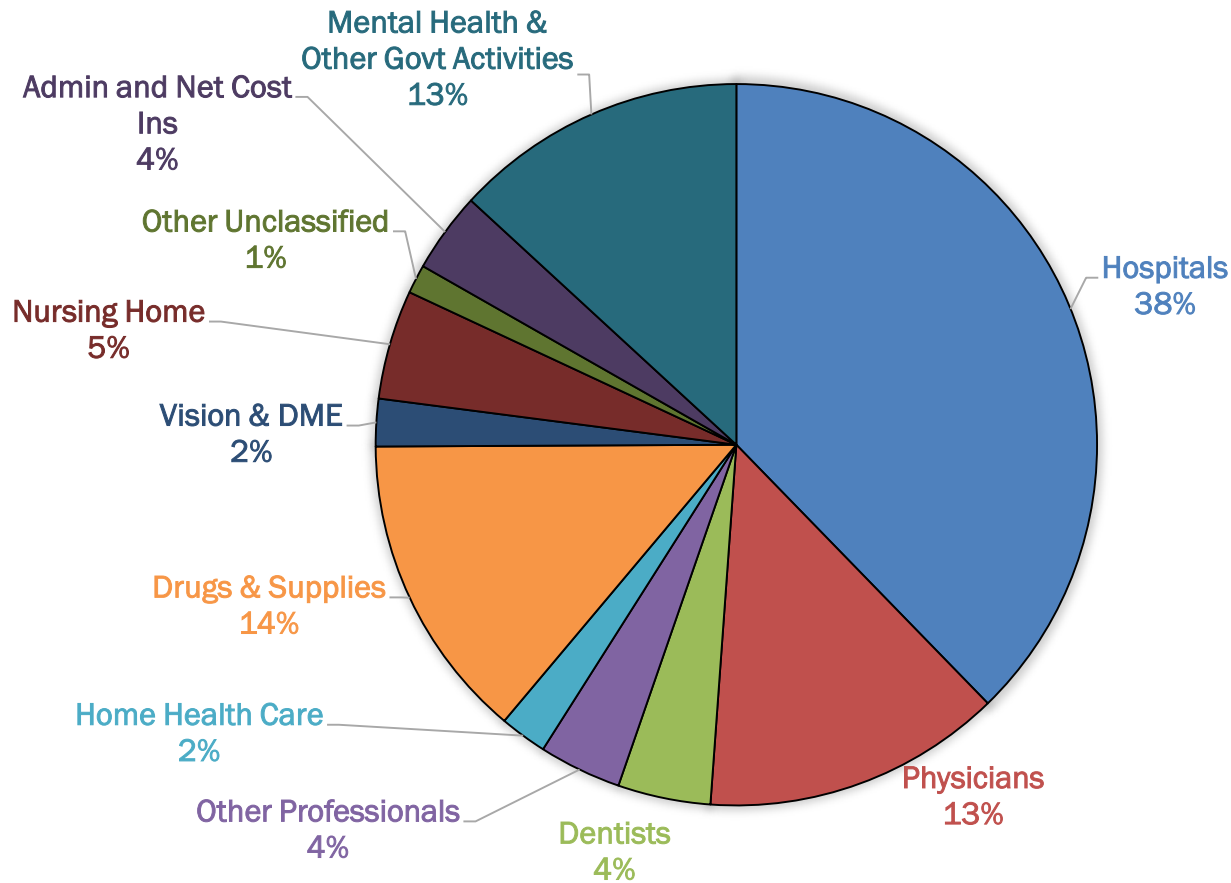

Provider services purchased: in and out-of-state - \$5.7 billion



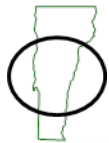

National Health Expenditures

The National Health Expenditure (NHE) accounts are the official estimates of total health care spending in the United States. The NHE is prepared by CMS, the Office of the Actuary, and National Health Statistics Group.

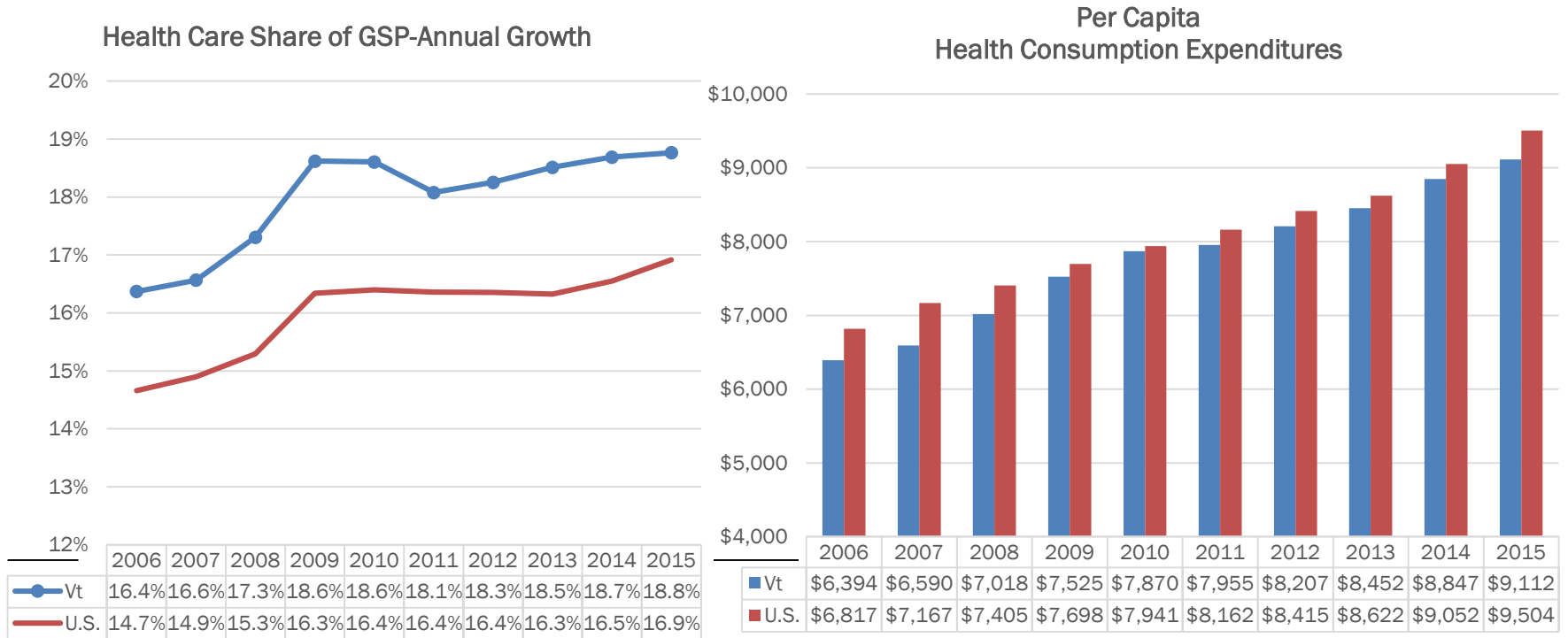
Since 1960, the NHE measures annual national expenditures for health care goods and services, public health activities, government administration, the net cost of health insurance, and investments related to health care. The data are presented by type of service, by source of funding, and by type of sponsor. Sponsors are those entities that make the final payment; private businesses, households, and governments. Household sponsor payments include contributions to health insurance premiums and out-of-pocket costs.

State provider and resident data are prepared every 5 years because they rely for their primary source of data on the quinquennial Economic Census. State provider and resident data was last reported for the year 2009.



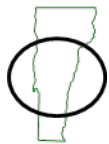

Vermont compared to CMS National Expenditures (NHE)



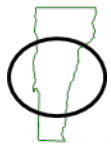
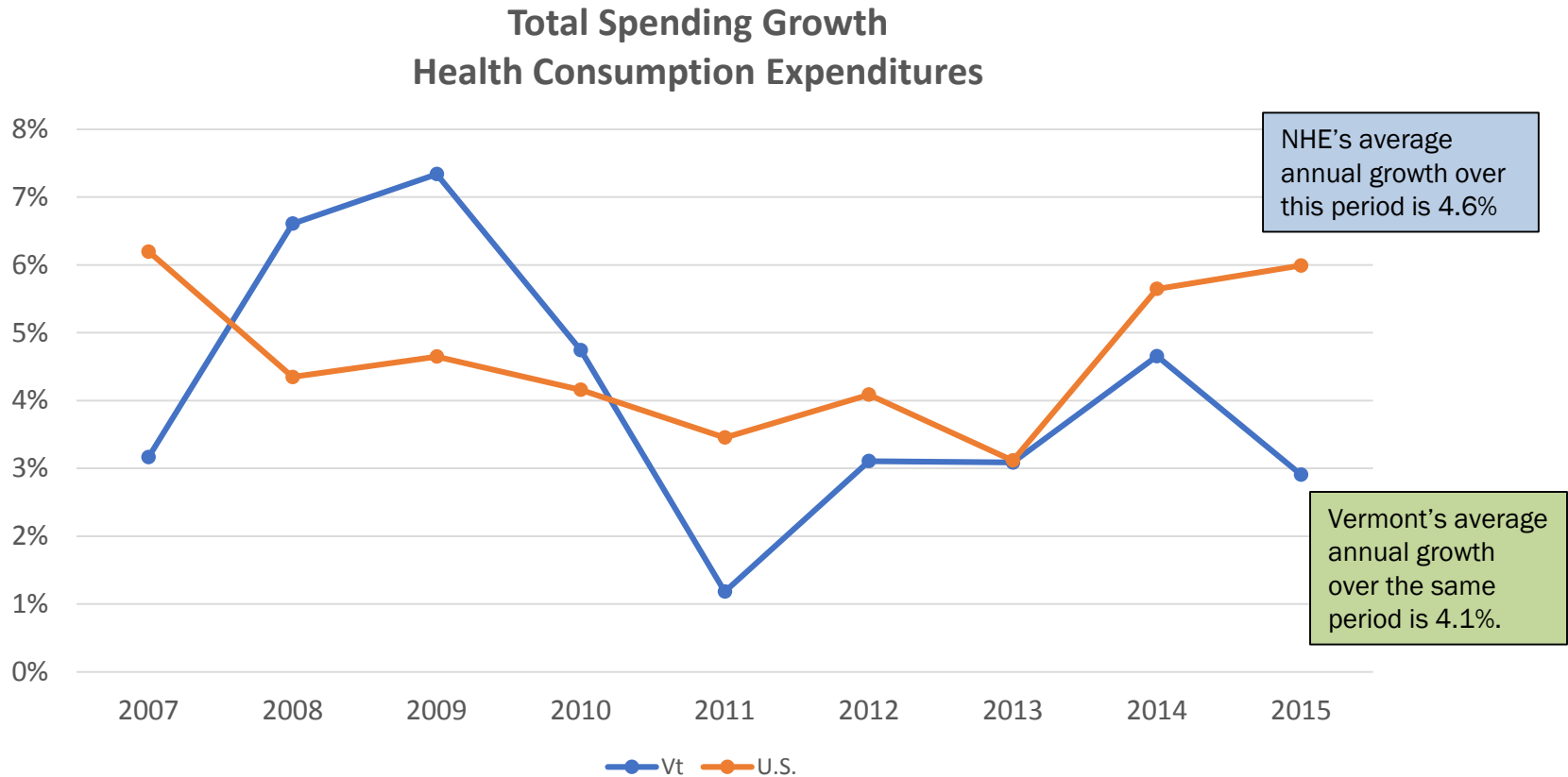

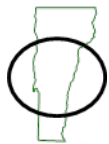
Vermont compared to CMS National Health Expenditures (NHE)

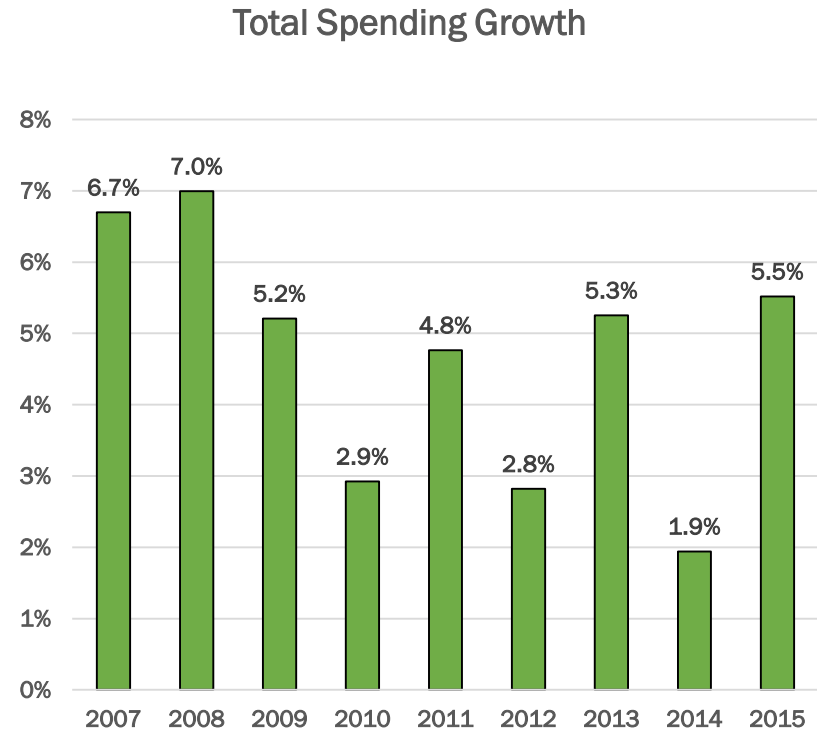
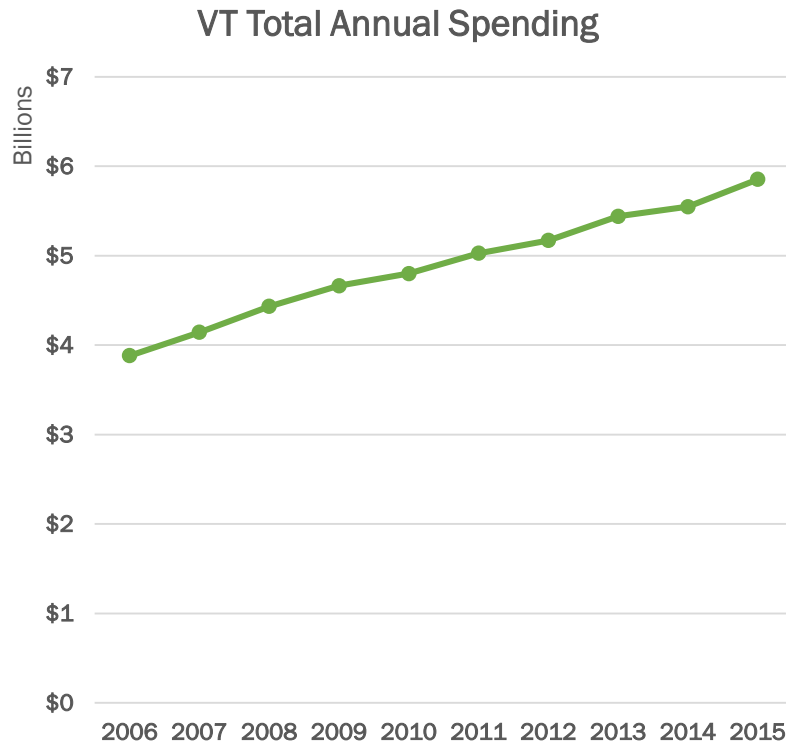

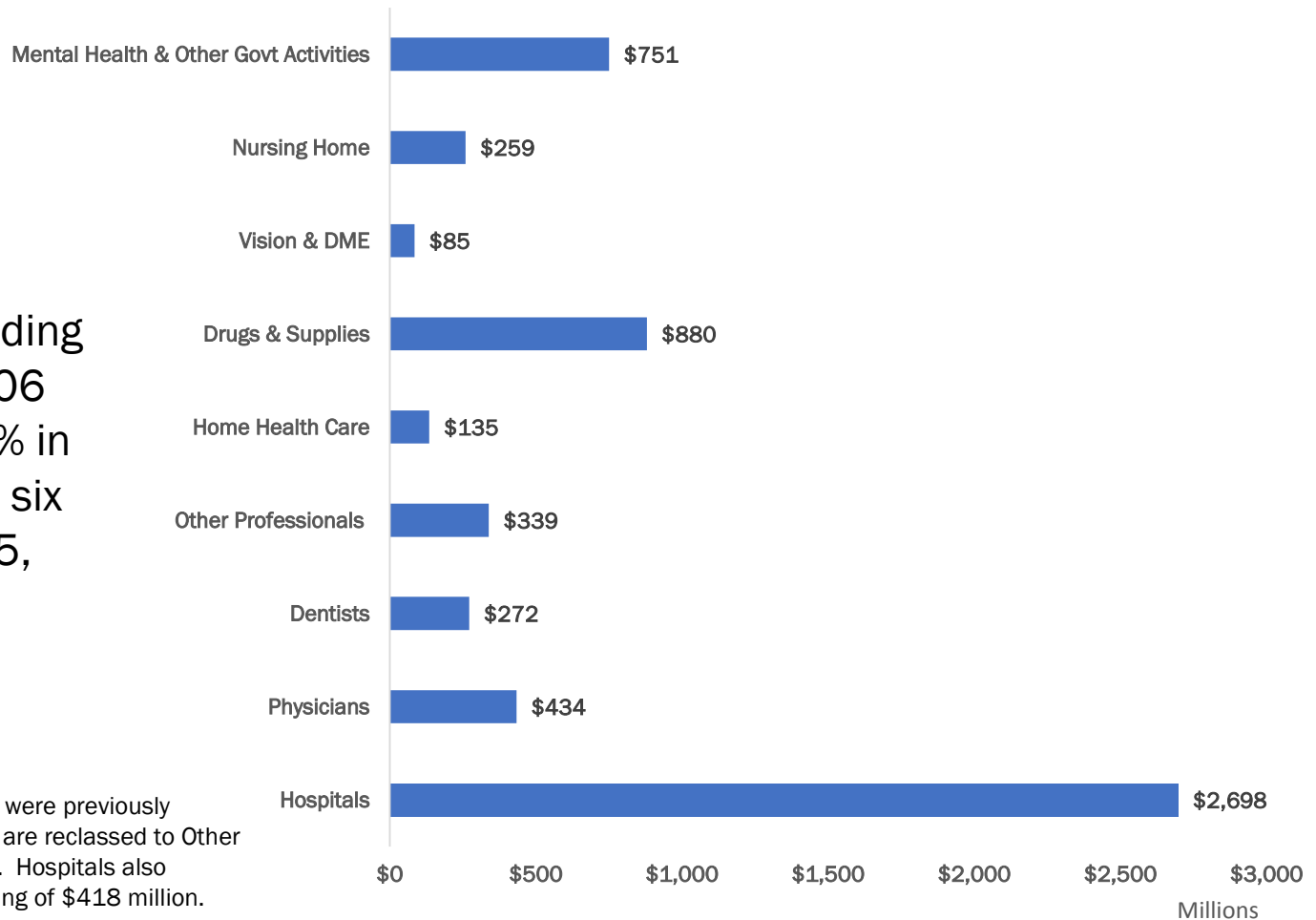
Spending increased from \$3.9 billion in 2006 to \$5.9 billion in 2015, an average annual increase of 4.7% for the period 2006-2015. The increase from 2014 to 2015 was 5.5%.

Provider spending increased \$306 million or 5.5% in 2015. For the six years 2010-15, the increase averaged 4%.



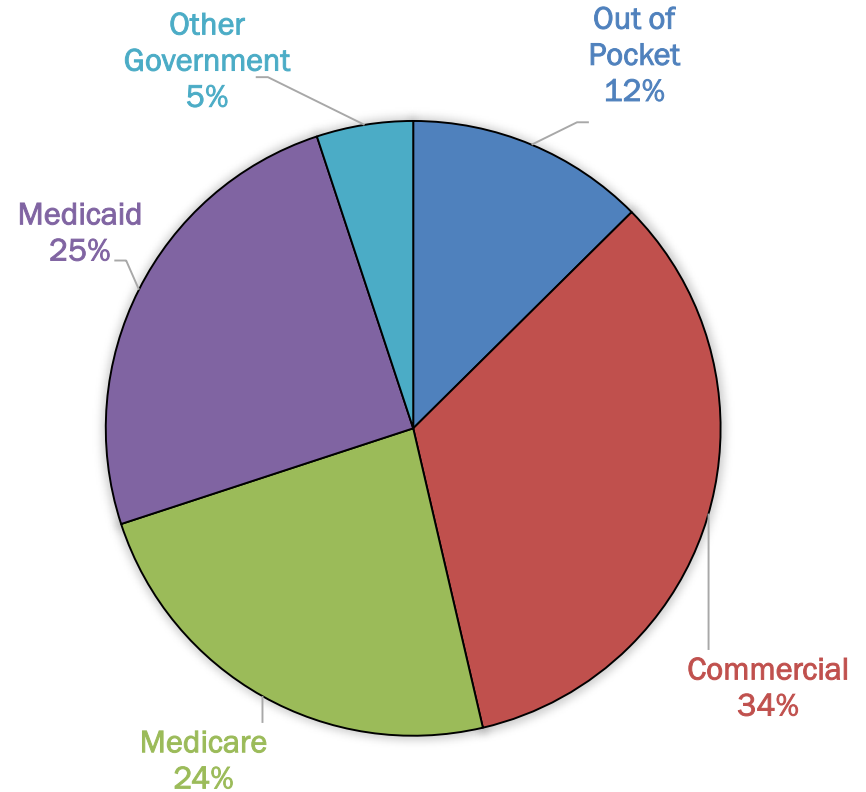
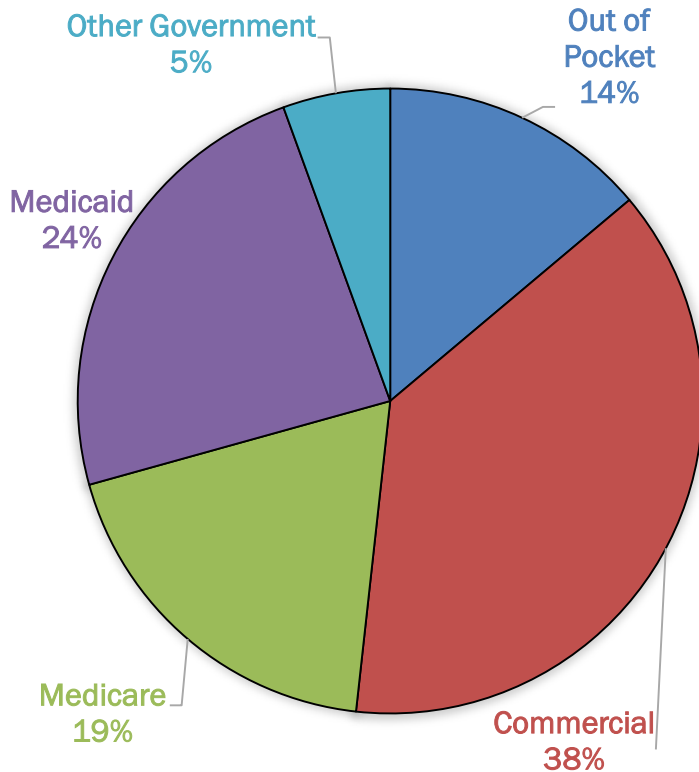

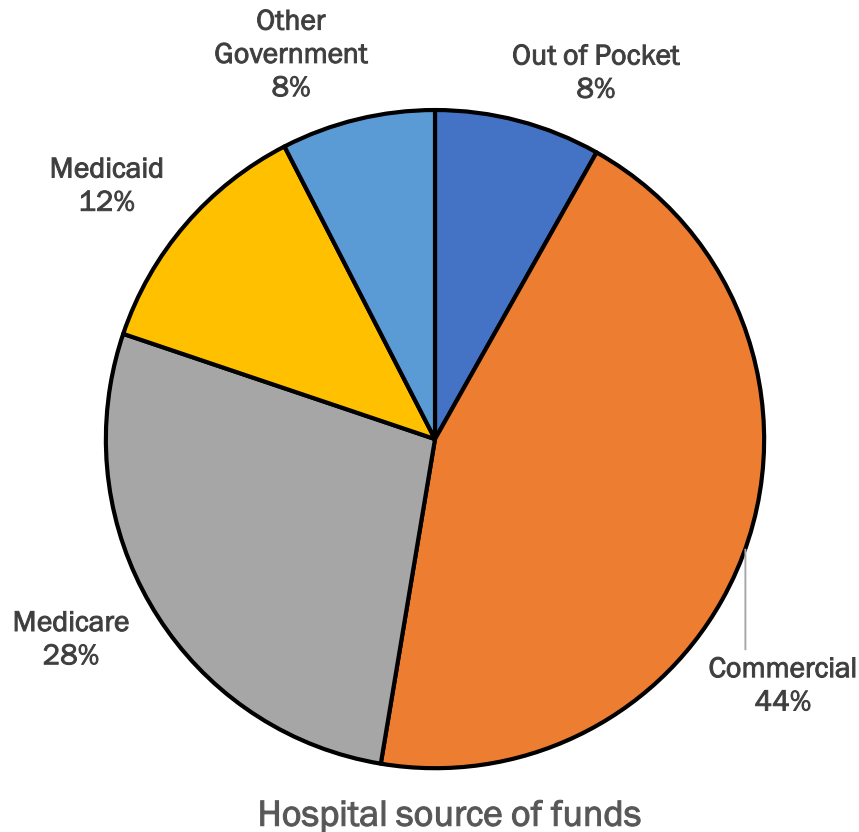
2006 Source of funds \$3.9 billion

2015 Source of funds \$5.9 billion

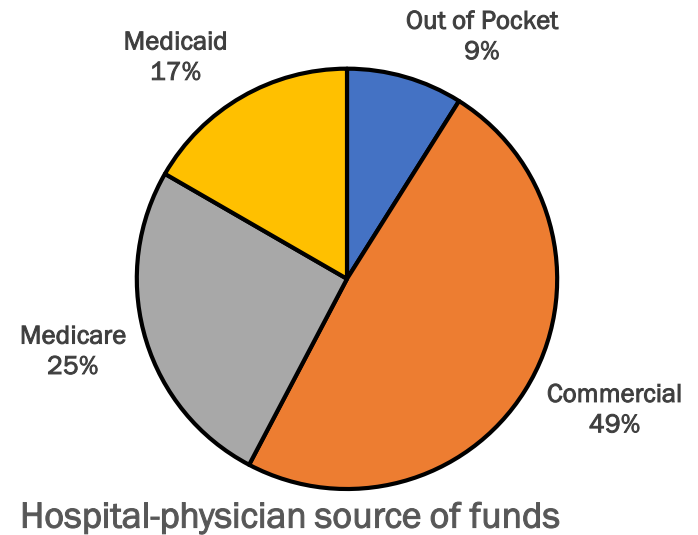

Hospital Spending \$2.7 billion



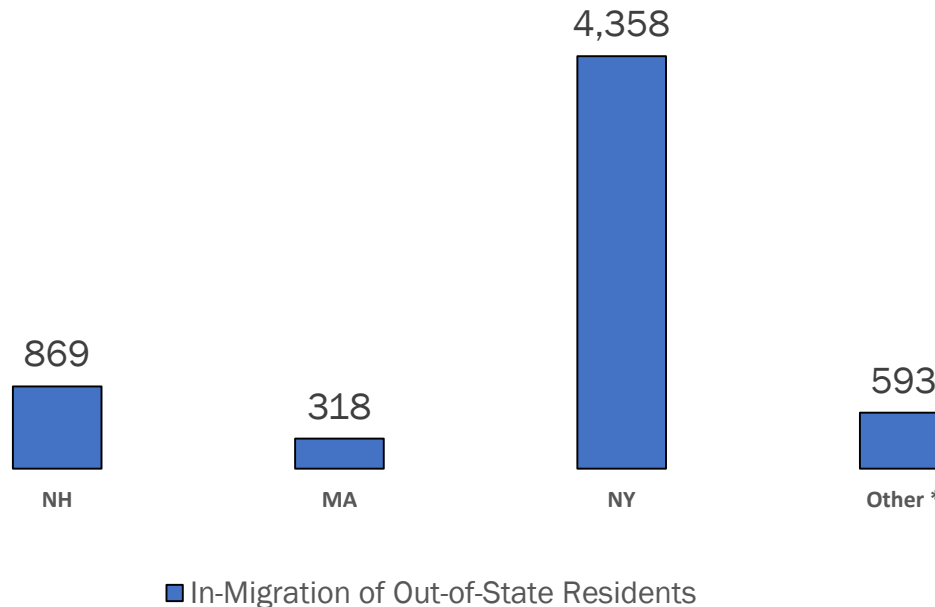
Of the total hospital spending, approx. 16% or \$418 million is reported as physician revenue. The community hospitals employ 1,006 FTE MDs.

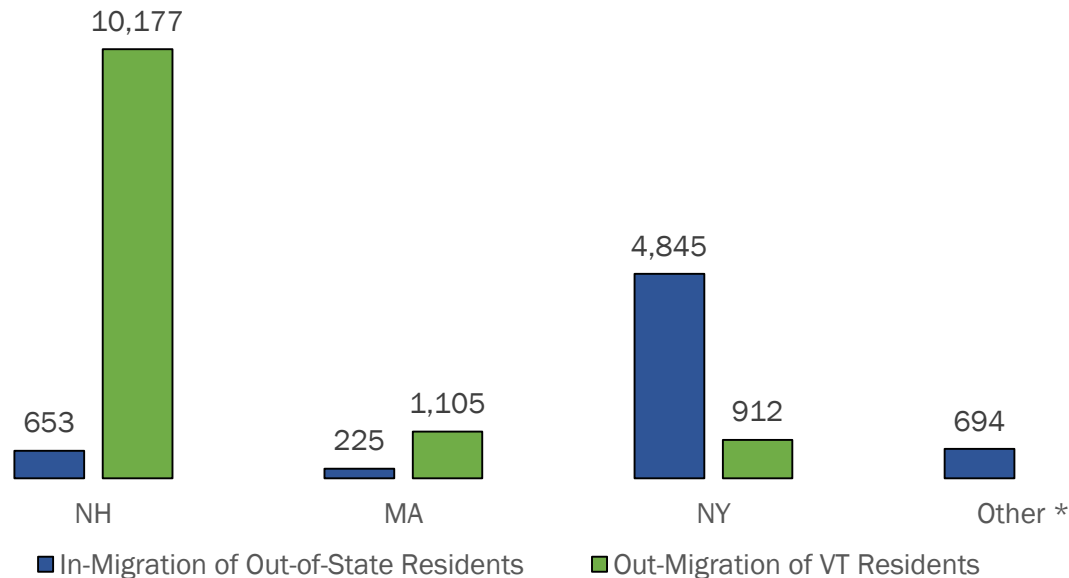
