 - i. 14 visits with his attributing primary care provider
 - ii. 9 visits with an ACO-participating independent specialist
 - iii. 3 visits with a non-ACO-participating independent specialist
 - iv. One emergency department visit in Florida for the flu
 - v. Hip replacement at UVMMC by a UVM-employed orthopaedic surgeon
 - vi. Inpatient stay at a skilled nursing facility for hip rehab
 - 2. A 31 year old female Montpelier resident with Medicaid who has the following:
 - a. Pregnancy and childbirth
 - b. Care at multiple locations including:
 - i. 1 well-exam and 1 illness visit with her attributing independent primary care provider
 - ii. Routine prenatal visits with a non-ACO-participating independent OB/GYN
 - iii. Delivery of baby at CVMC
 - iv. Transfer to UVMMC for inpatient stay due to a delivery complication
